
### SIGNIFICANT ACCOUNTING POLICIES :

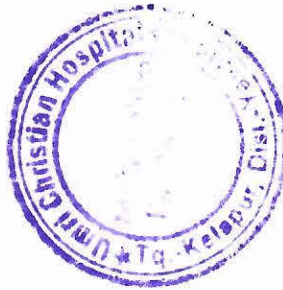
